PURPOSE:

This Request for Proposal (RFP) is issued by the South Dakota Science and Technology Authority (SDSTA) for consulting services for certifying up to ten (10) SDSTA's employees in master rigging training.

BACKGROUND INFORMATION:

SDSTA Mission: To enable compelling underground research in a safe work environment and to foster transformational science education.

The Sanford Underground Research Facility in Lead, South Dakota, advances our understanding of the universe by providing laboratory space deep underground, where sensitive physics experiments can be shielded from cosmic radiation. Researchers at the facility explore some of the most challenging questions facing 21st century science, such as the origin of matter, the nature of dark matter and the properties of neutrinos. The facility also hosts experiments in other disciplines—including geology, biology and engineering.

SCOPE OF WORK (SOW):

- 1) Primarily, the consultant will provide training at the Sanford Underground Research Facility located in Lead South Dakota for possibly up to ten (10) employees for the master rigging program.
- 2) Provide detailed cost break down, course(s) duration and certification and testing process.

Consultant will provide all training materials, tests and certification cards to all attendants in training.

EVALUATION CRITERIA:

In awarding a contract for consulting services for internal control examination for the organization, SDSTA will examine the following factors and criteria:

1. Applicants clearly describes and understands the scope of work to be used to perform the services.
2. Qualifications and experience of the applying consultant in master rigging training.

1. A brief Executive Summary.
2. A description of the applicant's general approach to master rigging certification.
3. A detailed budget that clearly identifies all expenses.
4. Credentials and qualifications of key personnel who will take responsibility for working directly on this project, including client references for each.
